Parish Councillors present: Cllr Nick Clowe, Cllr Clair Haswell and Cllr Wayne Fleming.

A member of the public enquired if the parish council were cutting the playing field. It was **AGREED** to discuss this further at point 14 as the parish council have been waiting for over a year for an AGM with the Mileham Playing Field Charity.

A member of the public stated that the junction that joins the Tittleshall Road and the Litcham Road is becoming dangerous as traffic oftens goes up the wrong side of the road. After much discussion, it was **AGREED** to put it on the Agenda for June to discuss the possibility of a two-way junction.

The playground was assessed as medium risk, and this is mainly due to lack of maintenance. Cllr Clowe went through the report and highlighted the areas in need of improvement. ACTION the Clerk to send a copy of the report, recorded delivery to both Trustees of the Mileham Playing Field Charity. She will also remind them that the AGM needs to be held in June, giving at least 14 days' notice. The Clerk will also contact TOP Garden Services to see if they can provide a quotation for cutting just the Pitt and if acceptable, proceed on that basis.
